The beaches and park lands are closed from 11pm to 6am and is strictly enforced. We have experienced late night activity in the more secluded areas. This results in disturbances to nearby residents, broken glass, trash, and other paraphernalia being left behind.

Crabbing, fishing, swimming, and mooring of boats is restricted to designated areas.

On all Maryland state waters, a personal watercraft may **not** be operated at **greater than 6 knots (6.9 mph)** within 100 feet of any shore, wharf, pier, bridge structure, abutment, or persons in the water. No one under the age of 16 may operate jet skis in Maryland waters...It's the Law!

## RAMPS and CREDENTIALS



### LTPOA IDENTIFICATION STICKERS

Rules and regulations are in place to control the unauthorized use of LTPOA property which includes the boat launching ramps, boat docking facilities, fishing and crabbing piers, beaches, parks, clubhouse, parking areas, and all LTPOA parklands and other property.

For access to, and parking on, LTPOA property, owners and bona fide tenants of London Towne are required to permanently display a current LTPOA sticker on all vehicles, vessels and trailers.

**Stickers are available for purchase from the Ramps & Credentials Committee at the Community Hall on regularly scheduled TUESDAY evenings 7PM – 8PM.**

**The 2017 schedule, the regulations and requirements – are all posted on the community calendar at [www.ltpoa.info](http://www.ltpoa.info).**

**In order to purchase stickers ALL applicants must present valid registration for all vehicles, vessels, and trailers (yes, even renewals).**

**Proof of ownership is also required. No exceptions.**

- **Owners must provide deed, property tax bill or settlement papers.**
- **Tenants must provide a copy of a current lease.**

A property owner sticker is valid for three calendar years and the cost is \$3.00 each. Renter and dependent stickers are valid for one calendar year and the cost is \$5.00 each.

Ramp keys are issued each calendar year and the cost is currently \$40.00.

Prior-year keys must be returned to avoid additional fees.

## Police Committee – December 2016

The London Towne Police Committee serves to provide coordination, direction and oversight to our cadre of Police Officers as they work to enhance safety and security around and within the Sections, Ramps, and Parks. Several Officers from the County Police work part time for LTPOA enforcing laws and LTPOA regulations. These Officers concentrate on protecting LTPOA property and residents but they have full police authority and will make arrests. The Officers will investigate unusual or unauthorized activities on and around LTPOA facilities and conduct traffic stops.

Thank you for your support and cooperation during the 2016 spring and summer. The Police Officers have done an outstanding job this year protecting our people and property but they could not have been successful without the help from LTPOA residents. The Police Committee plans to continue coverage during the fall and into the winter months.

As we approach the holiday season, please drive carefully and if you enjoy alcoholic beverages always designate and use a driver who has not been drinking. Please driver sober and have a safe and wonderful holiday season.

As a reminder, please check your vehicle and boat stickers. If the sticker expires at the end of December 2016; then be sure to renew your stickers in January 2017 so you avoid being ticketed because of an expired sticker.

During November County Police Officers arrested and charged a person with burglary for breaking into houses within our community here in London Towne. Additionally, two individuals were arrested stealing from automobiles in our community and were charged for theft from vehicles. We are hopeful these arrests will slow down or stop these types of activities that have been an ongoing problem.

## **Trip to Haliburton Scout Reserve – August 4<sup>th</sup> – 14<sup>th</sup> 2016**

*In August of 2016, Troop 815 of Londontowne, Maryland joined up with 3<sup>rd</sup> Toronto Scout Group of Toronto, Canada and a Scottish contingent of Scouts and Explorers from Ross and Sutherland district of Scotland for a week at Haliburton Scout Reserve, Scouts Canada. All together we had an international gathering of four nationalities as we were also joined by a Scouter from Gilwell, England for the week. It was a wonderful ten day trip.*

*This was a unique opportunity for Scouts to have international fellowship. Many lasting friendships were made and since returning both the Scouts and Scouters have still been communicating through email and social media. During our recent Webelos Woods event we also connected to Scotland briefly for a video conference. The Webelos thought it was amazing to talk to Scouts from another country. The Scots have also invited to host us for the Blair Athel Jamborette in Scotland in 2018.*

*Below is an account from one of our Scouts, Alexander Kline:*

We were all sleepy on August 4<sup>th</sup> at 6:00 AM, as we loaded our van for the 13 hour trip from Edgewater, Maryland to Camp Halliburton, three hours north of Toronto, Canada. On board were five Scouts, our Scoutmaster, and one parent. We had been planning this trip for years, and now the day had finally come, thanks to our Scoutmaster, Tim Mullady. Mr. Mullady has been good friends with the Scouts Canada leader, Scouter Dan Nelson for a long time. He visited the 3<sup>rd</sup> Toronto Scout Group in 2014 and we have been planning to do a joint venture ever since.

We had no problem getting across the border, and we soon found ourselves in a new country. Niagara Falls was our first stop. The view was beautiful from the Canadian side. We even went into the tunnels underneath the Falls. Everyone had to wear yellow rain-coats to keep from being drenched.

It was at the Falls that we met up with nine Scouts, Explorers, and their two leaders from Scotland who would also be joining us at Camp Halliburton. We all walked around for a while just talking about our countries and how excited we were to finally meet after years of planning. We also talked about our uniforms and how different they were. We'd never seen Scout uniforms with kilts! That night we were exhausted, and our two troops slept in the basement of a church in the city of Toronto.

The next morning, we were so happy to finally meet the seven Canadian Scouts and four leaders of 3<sup>rd</sup> Toronto Scout Group who would also be joining us on this adventure. All three troops got to know each other as we loaded the vans and buses for the last leg of our trip north. Soon, all three troops were on their way to Camp Halliburton.

It felt like forever, but three hours later, we finally arrived at camp. We unloaded our gear onto pontoon boats and headed to our camp site. The camp is on a lake, so we were all assigned canoes to get around. Otherwise, we would have needed to hike several miles to our activities. The camp was beautiful, but we found out quickly that the temperature was noticeably colder than in the U.S. This wasn't much of a surprise considering we were in Canada, but I should have thought about that before packing a week's worth of shorts and t-shirts.

In Canada and Scotland, troops have both boys and girls, which is different than in the U.S. So each of our patrols consisted of Scots, Canadians, and Americans with boys and girls in each patrol. The patrols cooked for themselves and my favorite dish was Shepherd's pie.

Some of the activities they offered were rifle shooting, archery, sailing, snorkeling, and an interesting one called "Trapper's Cabin" which taught us what trappers did and how they lived out in the forest. We learned about animal pelts and bones. One night, the staff took us on pontoon boats to star gaze. With no light pollution, we could see all of the constellations and even a shooting star now and then.

Badge trading was another highlight of the trip. Some of our Scouts traded Maryland badges for some really old and rare badges from Canada and Scotland. Speaking of trading, I brought two Maryland state flags and gave them to the Canadian and Scottish Scouts to keep.

As with all great adventures, this amazing week had to come to an end, so we packed our gear and prepared for the long drive home. As we drove away from the camp site, I thought back on everything we did. We accomplished so much that week, and although the mosquitoes were terrible, I would go back in a heartbeat.
