In accordance with Anne Arundel County laws and LTPOA regulations, **Fireworks** and **Alcohol** use are prohibited on LTPOA property. This will be strictly enforced.





The beaches and park lands are closed from 11pm to 6am and is strictly enforced. We have experienced late night activity in the more secluded areas. This results in disturbances to nearby residents, broken glass, trash, and other paraphernalia being left behind.

Crabbing, fishing, swimming, and mooring of boats is restricted to designated areas.

On all Maryland state waters, a personal watercraft may **not** be operated at **greater than 6 knots (6.9 mph)** within 100 feet of any shore, wharf, pier, bridge structure, abutment, or persons in the water. No one under the age of 16 may operate jet skis in Maryland waters...It's the Law!

LTPOA IDENTIFICATION STICKERS

Rules and regulations are in place to control the unauthorized use of LTPOA property which includes the boat launching ramps, boat docking facilities, fishing and crabbing piers, beaches, parks, Community Hall, parking areas, and all LTPOA parklands and other property.

For access to, and parking on, LTPOA property, owners and bona fide tenants of London Towne are required to <u>permanently</u> display a current LTPOA sticker on all vehicles, vessels and trailers.

Stickers are available for purchase from the Ramps & Credentials Committee at the Community Hall on regularly scheduled <u>TUESDAY</u> evenings 7PM – 8PM.

The 2017 schedule/calendar, the regulations and requirements are posted on the community website at www.ltpoa.info.

In order to purchase stickers ALL applicants must present valid registration for all vehicles, boats, and trailers (yes, even renewals).

Proof of ownership is also required. No exceptions.

- Owners must provide deed, property tax bill or settlement papers.
- Tenants must provide a copy of a current lease.

A property owner sticker is valid for three calendar years and the cost is \$3.00 each. Renter and dependent stickers are valid for one calendar year and the cost is \$5.00 each.

Ramp keys are issued each calendar year and the cost is currently \$40.00.

Prior-year keys must be returned to avoid additional fees.

LTPOA Public Water Committee Update, May, 2017



Public water committee members received over 51% positive responses on the proposed public water route expressing interested in moving to the next stage for obtaining public water. Next steps are as follows:

- Petition residents for interest in asking the county to explore the route. In this
 correspondence we will give a very rough estimate of costs based on past projects.
- If we have over 51% positive signed petitions we will ask the county to begin the technical survey work which will take several months.
- Costs per household are estimated between \$12,000 and \$15,000 (includes the individual public hook up to the water.) These costs can be attached to the sale of the house for low income residents and those over 60.
- We will not know the actual costs until the county has surveyed the route.

As a reminder, the proposed route is:

The intersection of Londontown and Mayo Road to the intersection of Mayo and Oakwood to the intersection of Oakwood Road and Shore Drive. Around Shore Drive past Webster to the intersection of 637 Shore and Bishop. The intersection of 637 Shore and Bishop to the intersection of Bishop and 700 Londontown Road.

Police Committee – June 2017

The 2017 spring and summer recreational and boating seasons are here! Be aware that schools are out and LTPOA will have increased pedestrians using the community property and many kids will play on the playground equipment and beaches. Please adjust your driving and keep your speed down to avoid a collision that could result in an injury or death. Every LTPOA member wants to maintain a safe and enjoyable summer experience in our community and neighborhood.

Please check your LTPOA Stickers displayed on vehicles, boats, and boat trailers to make sure the stickers have not expired. If a sticker is expired and you wish to use LTPOA parking areas, recreational areas, and boat ramps please come to the Community Hall on designated **Tuesday** evenings to obtain stickers or call the LTPOA Executive Director for an appointment to get stickers. The Police Officers do not want to give tickets or tow any resident's vehicles and the price of a sticker to register your vehicle is an inexpensive way to avoid tickets or tows. Since the busy recreational season is here, Police patrols and hours on patrols will increase from the winter season and the increased volume of patrols will continue all summer.

When you have guests who wish to accompany you to the beaches, parks, etc., please obtain a one day guest vehicle parking permit if their vehicle will be on LTPOA property. One day permits can be obtained for your guests at no cost from your Section President. Vehicles on LTPOA property without a permit are considered trespassing and subject to being towed at the owners expense – that could make for an unhappy picnic or cruise!

A question that comes up frequently is "How do I contact LTPOA Police Officers?" If anyone has an issue that should be dealt with by the Police then they should call 911 to report it to the Anne Arundel Police. Residents should not try to contact me or our Police Officers. When Officers are on duty for LTPOA they are considered in "Secondary Employment" status and the Officers keep the County Police advised of where and when they are working and maintain radio contact at all times. If residents call 911 or the non-emergency County Police number, the County will dispatch a Police Officer to handle the call. The Officer that is dispatched may be an on duty Officer or the Officer could be the Officer on duty to support LTPOA. Either way the County Police will dispatch an Officer to handle the call or complaint. If someone tries to call me or the Officer in secondary employment for LTPOA there will be a delay getting the problem resolved. The issue will be handled quicker and resolved directly by contacting the County Police and explaining your problem but do not ask the county operator to send the LTPOA duty Officer.

Police (cont.)

If there are problems (trespassing, parking, vandalism, etc.) involving LTPOA property, the Police Committee would appreciate an e-mail or other notification so we can make sure the Police Committee Members and our Officers stay on the lookout in the areas where violations are known to occur on LTPOA property. E-mail to the Police Committee should be sent to **Police.LTPOA@gmail.com.** Please e-mail or SMS pictures of observed improper parking, vandalism, etc. to the Police Committee if possible. You can leave a voice message, send SMS text messages, and send photos to the Police Committee on (443) 333-9490 and I will try to handle your request and get back to you in a timely manner.

Always report observed illegal activities, suspicious persons or actions, traffic violations, or any other law enforcement issue to the Anne Arundel County Police by calling 911.

Anne Arundel County 311

Anne Arundel County has launched a new 311 reporting system through an app. The system allows Anne Arundel County citizens to report **non-emergency** incidents and problems digitally through mobile devices. You can download the app through the App Store or Google Play. A simple signup process is required. The app enables Anne Arundel County citizens to report the following service requests:

- -Lost and found pets
- -Recycling cart requests
- -Broken recycling carts
- -Missing curbside collection
- -Bulk pickup scheduling
- -Potholes
- -Drainage complaints
- -County Recreation and Park concerns
- -Unregistered vehicles
- -Building violations

If you don't have a smart phone, you can call 3-1-1 to get help.



STANDARD MOSQUITO CONTROL OPERATING PROCEDURES - 2017-18

OPERATING PROCEDURES FOR SPRAYING OF ADULTICIDES (Treatment for adult mosquitoes):

Regular Surveillance and Control of Adult Mosquitoes: May 31 – October 3 Sunday-Thursday (A night of the week will be assigned to your community). Anytime between 7:00 p.m. - 2:30 a.m.

Spraying for adult mosquitoes will be done only if a Maryland Department of Agriculture Employee determines it is necessary.

Spraying will not be conducted during rain, in wind speeds exceeding 12 MPH, or temperatures above 89 F.

Thresholds for Ground Based ULV Treatments:

Landing Counts: 3 mosquitoes in a 2 minute count

Light Trap Collections:12 female mosquitoes in an unbaited light trap; 24 female mosquitoes in a baited light trap Conditions that threaten public health, such as mosquito borne disease

Adulticide Formulation and application rate

Permanone 30-30: Liquid

Permethrin mixed with Piperonyl Butoxide 0.0031 lbs/acre (Ultra Low Volume application) and

Mineral Oil

OPERATING PROCEDURES FOR USE OF LARVICIDES (Treatment for mosquito larvae):

County-wide Surveillance and Control of Larval Mosquitoes: April - October

Monday - Friday, 8:30 AM -4:00 PM

LARVICIDES TO BE USED:

Larvicide Formulations

Bacterial Larvicides:

VectoBac and Aquabac:

Bacillus thuringiensis var. israelensis Liquid, Granular

Spheratax:

Bacillus sphaericus Granular

Insect growth regulator:

Altosid (Methoprene) Liquid, Briquet, or Pellets

The **Mosquito Control Program does not spray for Midges** that swarm on homes, boats, trees and shrubs along many Anne Arundel County creeks and rivers. These non-biting insects develop in mud bottoms of slow moving water ways of low dissolved oxygen and will decline in numbers within a few weeks after they first appear.

- Your Community's assigned spray night is: Monday
 - Your community will only ever by sprayed on Monday nights during the 2017 season
- Spraying can occur anytime between 7:00 PM and 2:30 AM
 - The spray program will begin on May 31.
 - Spraying will not begin until the community has been notified and we have received the Community Notification Verification Form
 - October 3 is the estimated last day of spraying for 2017
- > Residents who do not wish their property to be sprayed may file and exemption.






Section 3: Karen Porter

Please Don't Feed the Geese





I have written several times before about the Canada Geese who apparently found a 'home' in the LTPOA shoreline. Last week, on my rounds of the beaches and parklands, I saw 3 mother & father geese with 8-10 new hatchlings. These geese do not leave our area. They are here year round and are invasive. There are several problems with these geese. First, please stop feeding the geese. This only encourages them to stay in this area & have more geese. Further, if you go to our beaches after the geese have 'visited', the shoreline is covered with their poop. Many of our children, who play in the sand at our beaches, are confronted by this poop. Our contractors clean the beaches at the beginning of spring and several times throughout the warm months, but cannot be there all the time. The only solution to clean beaches & waterways is to not encourage these geese from staying in this area. Further, these geese are polluting our water, stinking up our beaches and parkland & are dropping their poop all over LTPOA property. Please help by not feeding these geese.





Anne Arundel County Department of Health:

Beach Swimming Guide - To Swim or Not to Swim.. ?

After rainfall of 1/2 inch or more, all Anne Arundel County beaches are under a no swimming/no direct water contact advisory for at least 48 hours due to predicted elevated bacteria levels from rainwater runoff and increased health risks. Do not swim in cloudy, murky water. During the summer swim season, the Recreational Water Quality Monitoring Program will resume its routine sampling following the 48-hour period.
