Anne Arundel County 311

Anne Arundel County has launched a new 311 reporting system through an app. The system allows Anne Arundel County citizens to report **non-emergency** incidents and problems digitally through mobile devices. You can download the app through the App Store or Google Play. A simple signup process is required. The app enables Anne Arundel County citizens to report the following service requests:

- Lost and found pets
- Recycling cart requests
- Broken recycling carts
- Missing curbside collection
- Bulk pickup scheduling
- Potholes
- Drainage complaints
- County Recreation and Park concerns
- Unregistered vehicles
- Building violations



If you don't have a smart phone, you can call 3-1-1 to get help.



The beaches and park lands are closed from 11pm to 6am and is strictly enforced. We have experienced late night activity in the more secluded areas. This results in disturbances to nearby residents, broken glass, trash, and other paraphernalia being left behind.

Crabbing, fishing, swimming, and mooring of boats is restricted to designated areas.

On all Maryland state waters, a personal watercraft may **not** be operated at **greater than 6 knots (6.9 mph)** within 100 feet of any shore, wharf, pier, bridge structure, abutment, or persons in the water. No one under the age of 16 may operate jet skis in Maryland waters...It's the Law!

RAMPS and CREDENTIALS



LTPOA IDENTIFICATION STICKERS

Rules and regulations are in place to control the unauthorized use of LTPOA property which includes the boat launching ramps, boat docking facilities, fishing and crabbing piers, beaches, parks, Community Hall, parking areas, and all LTPOA parklands and other property.

For access to, and parking on, LTPOA property, owners and bona fide tenants of London Towne are required to permanently display a current LTPOA sticker on all vehicles, vessels and trailers.

Stickers are available for purchase from the Ramps & Credentials Committee at the Community Hall on regularly scheduled TUESDAY evenings 7PM – 8PM.

The 2017 schedule, the regulations and requirements – are all posted on the community calendar at [www. ltpoa.info](http://www.ltpoa.info).

In order to purchase stickers ALL applicants must present valid registration for all vehicles, boats, and trailers (yes, even renewals).

Proof of ownership is also required. No exceptions.

- Owners must provide deed, property tax bill or settlement papers.
- Tenants must provide a copy of a current lease.

A property owner sticker is valid for three calendar years and the cost is \$3.00 each. Renter and dependent stickers are valid for one calendar year and the cost is \$5.00 each.

Ramp keys are issued each calendar year and the cost is currently \$40.00.

Prior-year keys must be returned to avoid additional fees.

10th Annual “My London Towne” Photo Contest

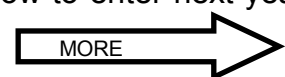
We would like to thank the judges of the Photo Contest. We had three local artists judge the photo contest this year. The artists were:

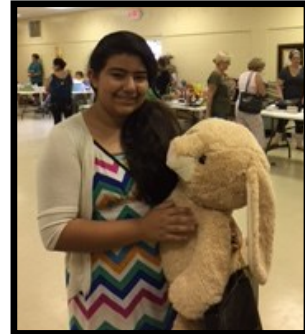

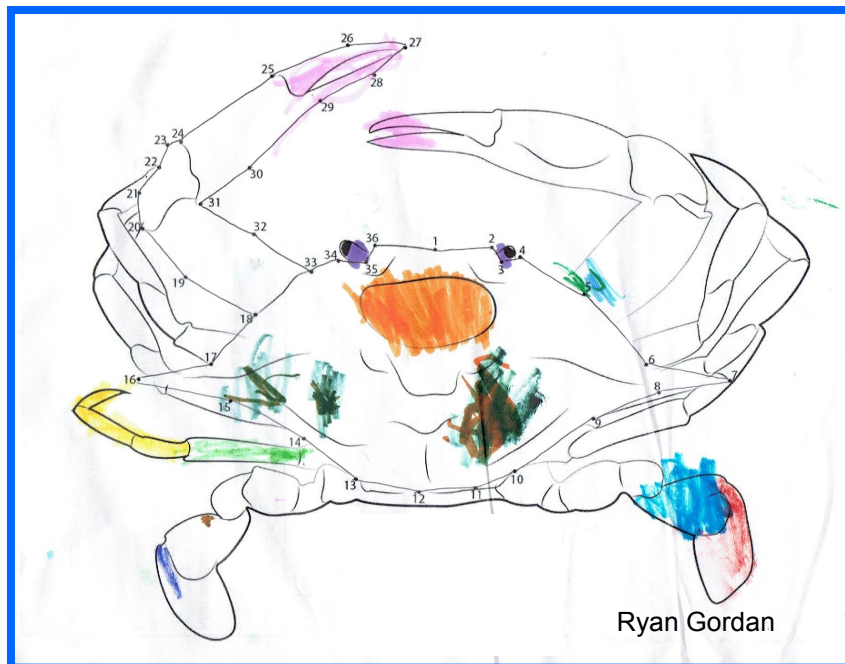

Police Committee – September 2017

The 2017 spring and summer recreational and boating seasons are winding down! Be aware that schools are open and many kids will play on the playground equipment and beaches in the evenings after school. Please adjust your driving and keep your speed down to avoid a collision that could result in an injury or death. Every LTPOA member wants to maintain a safe and enjoyable fall experience in our community and neighborhood for kids and residents.

Please check your LTPOA Stickers displayed on vehicles, boats, and boat trailers to make sure the stickers have not expired. Dates the Ramps and Credentials Committee is available for stickers can be found on the LTPOA calendar <https://localendar.com/public/LTPOA>. The Police Officers do not want to give tickets or tow any resident's vehicles and the price of a sticker to register your vehicle is an inexpensive way to avoid tickets or tows. Police patrols and hours on patrols volume will remain strong during the fall and winter seasons, so please cooperate by having valid stickers and following the parking and other LTPOA rules.

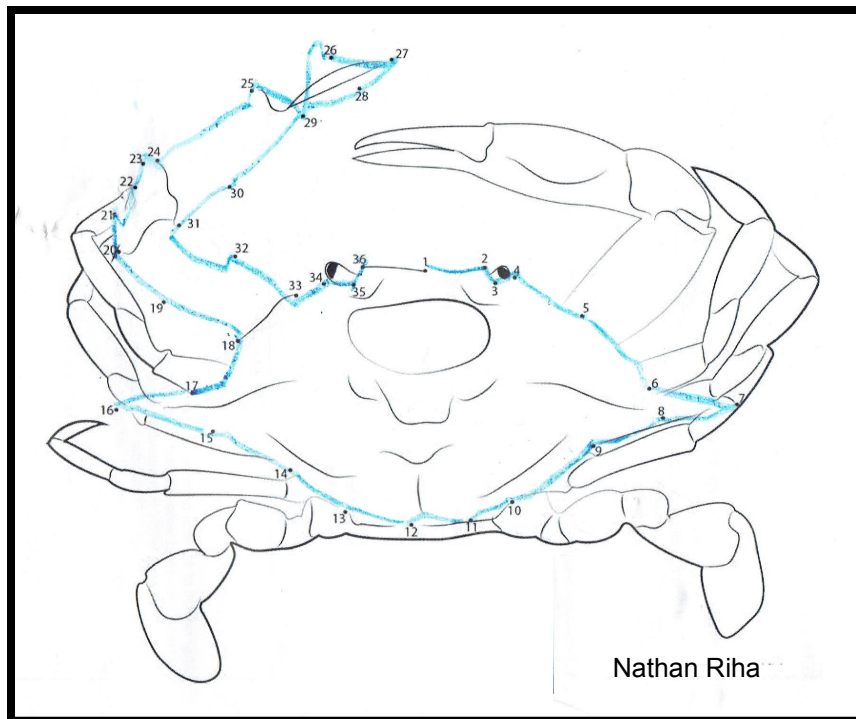
When you have guests who wish to accompany you to the beaches, parks, etc., please obtain a one day guest vehicle parking permit if their vehicle will be on LTPOA property. One day permits can be obtained for your guests at no cost from your Section President. Vehicles on LTPOA property without a permit are considered trespassing and subject to being towed at the owners expense – that could make for an unhappy picnic or cruise!

A question that comes up frequently is “How do I contact LTPOA Police Officers?” If anyone has an issue that should be dealt with by the Police then they should call 911 to report it to the Anne Arundel Police. Residents should not try to contact me or our Police Officers. When Officers are on duty for LTPOA they are considered in “Secondary Employment” status and the Officers keep the County Police advised of where and when they are working and maintain radio contact at all times. If residents call 911 or the non-emergency County Police number, the County will dispatch a Police Officer to handle the call. The Officer that is dispatched may be an on duty Officer or the Officer could be the Officer on duty to support LTPOA. Either way the County Police will dispatch an Officer to handle the call or complaint. If someone tries to call me or the Officer in secondary employment for LTPOA there will be a delay getting the problem resolved. The issue will be handled quicker and resolved directly by contacting the County Police directly and explaining your problem but do not ask the county operator to send the LTPOA duty Officer.

Police (cont.)

If there are problems (trespassing, parking, vandalism, etc.) involving LTPOA property, the Police Committee would appreciate an e-mail or other notification so we can make sure the Police Committee Members and our Officers stay on the lookout in the areas where violations are known to occur on LTPOA property. E-mail to the Police Committee should be sent to **Police.LTPOA@gmail.com**. Please e-mail or SMS pictures of observed improper parking, vandalism, etc. to the Police Committee if possible. You can leave a voice message, send SMS text messages, and send photos to the Police Committee on (443) 333-9490 and I will try to handle your request and get back to you in a timely manner.

Always report observed illegal activities, suspicious persons or actions, traffic violations, or any other law enforcement issue to the Anne Arundel County Police by calling 911.

The nettle nets in Section #2 swim area have worked this summer. I have done an inspection of each beach & found nettles in the swim areas of all beaches, EXCEPT Section #2. It was the hard work and persistence of President Dave Z & Committee member John Clementson. The Committee & the entire community needs to thank both of you for encouraging the committee to finally get the nettle nets up. The Committee will give a final report when the nets are taken down, cleaned/dried and put in winter storage.



The Committee has been very busy keeping the playground, beaches and parks clean, well-trimmed & the community has responded by using LTPOA property more this summer than in past summers. Thanks to all. Finally, after 30 years, the very first erosion project has been revived. The turn in Section # 2 was the first P & P + Erosion project. Over those years, trees have grown over the shoreline & prevented the grasses from growing and holding the bank in place. The committee finally got the trees trimmed/removed and we should have grasses growing all along the shoreline by next summer.

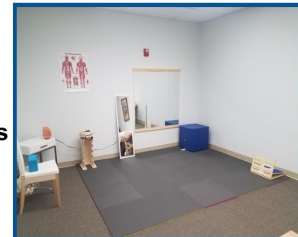



Approaches to Curbside Mailboxes


Dear Customer,

The Postal Service depends on you to meet postal requirements regarding delivery and collection of mail to curbside boxes. *Please keep the full approach and exits to your mailbox clear, as illustrated in the examples below.* Removing trash cans, snow, vehicles, and any other objects from the area allows the carrier to deliver your mail safely and efficiently without exiting the vehicle.
