So what is going on in London Towne?

This year we will rebuild the swimming area at Section 3. The Park and Planning and Erosion Committees are working together to get this project completed in time for summer. Many of you may have noticed that the Section 3 swimming area has gotten smaller and smaller each year due to erosion. At high tide, there isn't even enough sand to put a beach towel out. The restoration of the swim area has been in the works for years; and thankfully, we now have the funds to complete this much needed project.

We will also complete an erosion and park

restoration project at Gray Point Park in Section 1. This is another project that has been in the planning and budget process for some time. Gray Point Park has suffered from serious erosion for years, and the park, path, and seating areas have also suffered greatly. The Erosion and Park and Planning Committees are teaming together to complete this important project as well.

You will see our landscapers working on our park areas and on the upkeep of our playgrounds as part of our annual maintenance program. The Clubhouse is also scheduled for some interior improvements this year.

Our Security Committee has been hard at work hiring new officers and preparing a schedule to make sure we have sufficient coverage over the busy spring and summer seasons. Some of you may not know that we hire off-duty police officers to patrol our public areas and enforce our rules, which helps make London Towne the safe community it is.

The beaches and park lands are closed from 11pm to 6am and is strictly enforced. We have experienced late night activity in the more secluded areas. This results in disturbances to nearby residents, broken glass, trash, and other paraphernalia being left behind.


Crabbing, fishing, swimming, and mooring of boats is restricted to designated areas.

Personal watercraft use (jet skis and propel driven) is prohibited within 100 feet of the shoreline, piers, and persons. Speed is not to exceed 6 knots and wave jumping is not permitted. No one under the age of 16 may operate jet skis in Maryland waters...It's the Law!

Park and Planning Committee



There are several major projects that the Park & Planning committee is involved in this spring. Darryl W. Christian from The Riva Trace Baptist Church Outreach Program has generously offered the services his volunteers to help LTPOA clean the shoreline. Each winter, the shoreline at Sections 4 & 5 become littered with debris both from the water and blowing trash. This litter and trash accumulates on our plants and sea grass and inhibit the growth of new vegetation. This clean up will on April 9, 2011 at 9:00AM along the shoreline from the ramps in both Section 4 & 5 and working around until all the trash is cleaned up. PLEASE come out and join this volunteer effort. Darryl is asking for nothing in return but a good turn out of LTPOA volunteers to help with this project would be greatly appreciated.



Our contractor, ShoreLine Design, will be completing the erosion & Park project in section 1. This project will go from the beach area all around Gray's Point. This area has been eroding for years and LTPOA finally has the financial resources to address this project--THANKS to the LTPOA community. The next joint erosion and parks projects are to redesign and expand the beaches at Sections 3 & 2.

The Park & Planning committee will continue to install new playground equipment as



soon as funds are available. We know the new swings at Westminster Park and Bayview Park are getting great use and encourage more people to come enjoy them. We hope to be able to have a set of swings with bucket seats just for the very small kids soon.

The last item of concern for the committee is the parking along Shore Drive. The Board of Directors requested the Park & Planning committee to inspect the No Parking signage along Shore Drive. The goal is to protect the LTPOA parkland. Some people park on the grass [and others drive across the parkland]. This

is not just digging ruts into the parkland but is a dangerous hazard to residents using the park land. Please keep vehicles off the LTPOA park land

Credentials and Ramps

The Ramps & Credential
Committee

Ramp keys, vehicle, vessel and trailer stickers are available at the community hall Monday evenings from 7PM to 8PM.

We will be at the community hall every Monday in March.

In April we will be there the 4th, 11th and 18th.

In May we will be there the 2nd, 9th, 16th and 23rd.

Check the next Conciliator for future dates.

All vehicles, vessel and trailers must have a **current** LTPOA sticker to use LTPOA facilities and parking areas.



PLEASE NOTE: You must bring current vehicle and vessel registrations to obtain LTPOA parking and ramp stickers. If you do not have your registration with you we can not issue stickers and you will have to wait until the next night we are at the hall.

Fees for property owner's stickers are \$3.00 valid for three years; fees for renters and dependants are \$5.00 valid for one year. Documents required for stickers are proof of property ownership (deed/tax bill); tenants/renters must provide a current lease. We will also need current vehicle, boat or trailer registrations.

Ramp fees are \$40.00 for the year. If you are a previous ramp user, bring back your old ramp key to avoid an additional fee.

PLEASE NOTE: If you fail to return your previous year's ramp keys you will be charged the lost key fee.

GRAY-MOTT YOUTH SCHOLARSHIP

The **London Towne Property Owners' Association** Has established educational scholarships to assist current school year high school graduates in continuing their education at an accredited post-secondary institution of their choice.

This scholarship was instituted in 1989, in recognition of the invaluable contributions made by **Mr. Charles Gray and Mr. Ralph Mott** to the community of London Towne. As a reminder of their contributions and in their memory, we dedicate those scholarships awarded to the young people of our community who choose to follow in the path of these two men through **volunteer community service**.

The scholarship awards will consist of two (2) **\$1000.00 non-renewable** grants for two graduating students, who will continue their education at either a four year college or university, two year junior or community college, or at a trade, technical, or business school.



The following eligibility requirements will govern:

- Son/daughter of a resident of the London Towne Community
- Demonstrated community involvement Satisfactory high School academic achievement (min. 2.0)
- Character recommendations / work related references

Police Committee

Since July 1, 2010, LTPOA Officers have patrolled more than 750 hours or the equivalent of over 200 shifts. Shifts were scheduled to provide maximum coverage during the weekdays, weekends, evenings, and night into early morning. Warnings and tickets have been issued for anyone trespassing on LTPOA property, parking in no parking areas, or in violation of other LTPOA requirements. In August 2010 LTPOA instructed Officers to tow vehicles trespassing on LTPOA property if the sticker was expired more than a year or does not display a sticker. Several vehicles were towed and several tickets were issued for illegal parking. It appears that individuals who repeatedly ignored LTPOA requirements and parking laws have gotten the message and are now complying with LTPOA. The Police Committee does not want to restrict legitimate use of community property but the Committee wants to stop unauthorized use that may prevent LTPOA residents and property owners from enjoying the parks, shoreline, and recreational areas reserved for their use.

The recreational season is approaching quickly. Please check the LTPOA stickers on your vehicles and boats to make sure the stickers are not expired. Stickers are inexpensive and provide you with full access to LTPOA property. Without a current sticker you may be towed from LTPOA property at your expense, so please check those stickers.

If there are problems (trespassing, parking, vandalism, etc.) involving LTPOA property I would appreciate an e-mail or some type of notification so I can make sure the Police Committee Members and Officers stay on the lookout in the areas where violations are known to occur on LTPOA property. E-mail to the Police Committee should be sent to Police.LTPOA@gmail.com. Please e-mail pictures of observed improper parking, vandalism, etc. to the Police Committee if possible.

Any question about towed vehicles, trailers, etc. should be directed to Edgewater Truck Center (410) 956-3663 or (410) 867-3479.

Always report observed illegal activities, suspicious persons or actions, traffic violations, or any other law enforcement issue to the Anne Arundel County Police by calling 911.

“How do I contact LTPOA Police Officers?”

If anyone has an issue that should be dealt with by the Police then they should call 911 to report it to the Anne Arundel Police. Residents should not try to contact me or our Police Officers. When Officers are on duty for LTPOA they are considered in “Secondary Employment” status and the Officers have to keep the County Police advised of where and when they are working and maintain radio contact. If residents call 911, the County will dispatch a regular, on-duty Officer to handle the call or if no Officer is available they may dispatch the LTPOA duty Officer to handle the call. Either way the County Police know that our Officer is on duty and radio contact will be made if that Officer is in a position to handle the call or assist another on duty Officer. If someone tries to call me there will be a delay getting the problem resolved. The issue could be handled quicker and resolved directly by contacting the County Police

Are your animals good neighbors? Logan Hottle

I have always disliked being the one to write about something that might be interpreted as nagging and critical. But, a problem you might think is under control is not. While most people are careful about where their pets deposit their offerings, there are some who seem to think the request to clean up does not apply to them. The Sections have made it easy for you to pick up after your dog and/or cat by having plastic bag dispensers and trash cans around the community. It's not just nice to clean up, it's the law.

The statements in this article are paraphrased or quoted from Anne Arundel County Code Article 12, Title 4, Subtitle 4-102—Public Safety Threat. To read the whole code, go to the County Animal Control section on the Anne Arundel County website.

No time of year is the right time to let **dogs or cats** “run at large.” The County says an animal is at large “when it is off the property of an animal's owner and not leashed and not under the control of a responsible person.” Quoting further from the County Code: “Anyone who owns or harbors a cat or dog 4 months of age or older must have the animal vaccinated for rabies and be able to provide proof of vaccination.”

“The owner of any dog or cat 4 months of age or older must obtain a license for the animal.”

“The owner of any animal shall be responsible for the removal of any excreta deposited by his or her animal on public walks, recreation areas, or private property other than his own.” Many people do not know that the property along the shoreline in London Towne is all private property and therefore the requirement to clean up after your pet is covered by this Article. Taking a walk along the shore and stepping in something soft, brown and smelly is one of the least appealing experiences of life. Also, that stuff is a health threat.

Further, “Anyone violating Title 4, Subtitle of Article 12 may be subject to a fine not less than \$50.00 and up to \$500.00.” That's a lot of money to be fined just because you don't want to leash your pet and/or clean up after it.

The final point is that one of the primary sources of pollution of the Chesapeake Bay is caused by animal “excreta” getting into streams, rivers and the Bay. For the health and safety of your pet as well as your neighbors, their kids, and the Chesapeake Bay, no season is the time to let your pets roam. Let's all do our part to keep the community clean and safe from bacteria. A wonderful bonus is that we'll be doing just a little bit to Save the Bay.


